

UNECE Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters

UN Doc. ECE/CEP/43 (1998), signed in Aarhus, Denmark, on 25 June 1998. 38 International Legal Materials (1999) 515.

- **As of 2018; 47 Parties** (ratifications) = EU and all its MS + EECCA (not Russia)...
- **PRTR (35 Parties)** and **GMO amendment (30 Parties)**



The Aarhus Convention

THREE PILLARS

- Art. 4-5: Environmental Information...
- Art. 6-8: Public Participation...
- Art. 9:....Access to Justice...



3. Access to justice (A2J)

Article 9.2-9.4

Access to a review procedure before a **court of law or another independent body**

(Article 6 ECHR)...

...challenge the **substantive and procedural legality** of any **decision, act or omission...**

...adequate and effective remedies,
including injunctive relief...

...and be fair, equitable, timely and not prohibitively expensive...

Compliance Mechanism

- *Independent and impartial experts nominated by the Parties and Public*
- *The Public Trigger, open sessions*
- *Recommendations (“decisions”)*
- *Report to MoP; advice & recommendations, ask for strategy, declaration of non-compliance, cautions, suspension...*

■ Public Participation and Access to Justice

- ✿ *Directive 2003/35/EC → EIA-directive (2011/92), IED (2010/75), also in other directives, such as SEA (2001/42), WFD (2000/60), ELD (2004/35)...*
- ✿ *Article 9.3: Declaration → MS, proposal COM (2003) 624 → CJEU...*

■ Internal affairs

- ✿ *Regulation 1367/2007 → CJEU...*

Rights and interests...

Article 47 of the EU Charter...

Everyone whose **rights and freedoms** guaranteed by the law of the Union are violated has the right to an **effective remedy** before a tribunal in compliance with the conditions laid down in this Article.

Article 19 Treaty of the EU (TEU)

Member States shall provide remedies sufficient to **ensure effective legal protection** in the fields covered by Union law.


